### PURPOSE OF MOU

In particular, this MOU is intended to

- 1. Assist final year's UG/PG Course students from all departments in job placement.
- 2. Assist the UG/PG Course students in getting Summer Internships wherever applicable.
- Conduct trainings, Seminars, Workshop. Lectures on Entrepreneurship development and Skill Development.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:

#### Clause 1

#### CO-OPERATION

1.1 Both parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations. The parties shall keep each other informed of potential opportunities and share all information that may be relevant to successfully conduct the above mentioned purpose of the MOU.

#### SCOPE OF THE MOU

Both parties believe that close co-operation between the two would be a major benefit to the student community of the institution to enhance their skills and knowledge and find better career opportunities in their desired field and area of expertise.

- 2.1 The Second Party will give valuable inputs to the First Party about the courses conducted, number of students appearing in their final year/semester examination, teaching and training methodology so that the students fit into the industrial scenario meaningfully.
- 2.2 The First Party will work on behalf of the potential employers and will facilitate the placement facilities for the eligible students to participate in the placement process as set by the companies. First party will share insight of the the latest developments /requirements of the industries; the Second Party to permit the authorized people of the First party to visit and interact with the students. The First party or the Second party individually or jointly issue necessary permissions to the Students to visit its group companies and also involve in Industrial Training Programs for the Second Party as and when applicable. The industrial training and exposure provided to students through this association will build confidence and prepare the students to have a smooth transition from academic to working career.
- 2.3 The Second Party will extend the necessary support to conduct any workshop, seminar, job fairs in the Campus with prior permission in writing. The Second party will inform their students about any cost/other requirements to be managed by the students to appear for any training/placement/internship program and will collect as and where applicable.
- 2.4 Placement charges/Training/Internship charges if any to be paid by the students will be informed to the Second party by the First Party in writing before any such event and that will be completely optional for the students to participate in any such event.
- 2.5 All logistical arrangements to participate in any placement/Internship/Training program have to be made by the students participating in such events and the First Party will not be responsible to provide any such facility.
- 2.6 The First Party will actively engage to help the delivery of the training and placement of students of the Second Party into internships/jobs.

#### Clause 3

## VALIDITY

- 3.1 The validity of the agreement is two years from the date of agreement.
- 3.2 Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their obligations.
