MEMORANDUM OF UNDERSTANDING

This **Memorandum of Understanding** (hereinafter called as the 'MOU') is entered into on this the **10th** day of December, **2024**.

BETWEEN

Guru Gobind Singh Educational Society's Technical Campus (GGSESTC), Chas, Bokaro, Jharkhand represented herein by its Director **Dr. Priyadarshi Jaruhar** (hereinafter referred as "**First Party**", the institution which expression, unless excluded by or repugnant to the subject or context shall include its successors – in-office, administrators and assigns).

AND

Padmashri Dr. V. B. Kolte College of Engineering (PDVBKCE), Buldana, Malkapur, Maharashtra, represented herein by its Principal, **Dr. A. W. Kharche** (hereinafter referred to as "**Second Party**", company which expression, unless excluded by or repugnant to the subject or context shall include its successors – in-office, administrators and assigns).

(First Party and Second Party are hereinafter jointly referred to as 'Parties' and individually as 'Party')

WHEREAS:

- A) The First Party is a college of engineering & management founded in 2011 by Guru Gobind Singh Educational Society. The college is affiliated to VBU, Hazaribagh and JUT, Ranchi, and offers AICTE approved two programs; B.Tech. and MBA. The B.Tech. degree offers branches in Mechanical, Civil, Computer Science, Electronics & Communication, and Electrical & Electronics engineering. The MBA program offers three specialization; Marketing, Finance, and HR. The serene campus of the college is located at NH-32 in Chas, Bokaro district of Jharkhand, towards Purulia.
- B) The Second Party is an engineering college Set up by Lok Sewa Shikshan Bahuuddeshiya Mandal in the year 2010. The college is



approved by AICTE, Ministry of HRD, New Delhi and affiliated to Sant Gadge Baba Amravati University, Amravati, Maharashtra. At present, it offers B.E. Programs in Civil, Computer Science, Electrical, and Mechanical engineering; M.E. Programs in Computer Engineering, Electrical Engineering (Electronics & Power) and Mechanical Engineering (CAD/CAM); and Diploma Courses in Electrical, Computer Science and mechanical Engineering.

- C) Both the Parties believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.
- D) With recognition of their strength in research in one or more disciplines of science, technology and management and their mutual interest in engaging themselves in research/academic cooperation, both the Parties agree to set up a MOU to establish a programme for research/academic collaboration in areas of mutual interest.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:

CLAUSE 1: SCOPE OF CO-OPERATION

- 1.1 Both the Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations to achieve their Institutional objectives. They shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.
- 1.2 Both the Parties agree to engage in joint research or development programmes by different funding agencies. Any financial aspects or other terms and conditions for such cooperation will be dealt separately.
- 1.3 Both the Parties agree to exchange the information on research and educational programmes, teaching and learning materials with due approval of competent authority of both the institutions.

- 1.4 Both the Parties agree to encourage collaboration between the faculties of the two institutions. The scope of such collaboration includes faculty exchange program, short term as well as fixed term visiting assignments at each other's institution. Such scope may also be extended to exchange of students between both the institutions for R&D projects and academic purpose.
- 1.5 Both the Parties agree to extend their cooperation for various accreditation (such as NAAC, NBA) and ISO certification process.
- 1.6 Both the Parties agree to conduct seminars, conferences, workshops and short term courses jointly and to invite each other's faculty/students to participate therein.
- 1.7 Both the Parties agree to extend their cooperation in providing Internship and Placement opportunities to the students at each other's campus facility.
- 1.8 Both GGSESTC and SEC shall appoint a nodal officer for mutual correspondence and coordinating the activities under this MOU.
For First Party: Director, GGSESTC, Bokaro
For Second Party: Principal, PDVBKCE, Bildana, Malkapur

CLAUSE 2: GENERAL AGREEMENT

- 2.1 There is no financial commitment on the part of either Party to take up any programme mentioned in this MOU. If there is any financial consideration, it will be dealt separately.
- 2.2 It is expressly agreed that both the Parties are acting under this Understanding as independent contractors, and their relationship established under this MOU shall not be construed as a partnership.
- 2.3 Neither Party is authorized to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party.

- 2.4 Neither Party shall have, nor represent itself as having, any authority under the terms of this Understanding to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.
- 2.5 Both the Parties respect each other's right to intellectual property. The intellectual property rights that arise as a result of any collaborative research or activity under this MOU will be worked out on case-to-case basis by the competent authorities of both the institutions, and will be consistent with officially laid down IPR policies of the two institutions.
- 2.6 This Agreement will be valid until it is expressly terminated by either Party on mutually agreed terms, during which period both parties will take effective steps for implementation of this MOU.
- 2.7 Either Party may terminate this MOU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their obligations.
- 2.8 Any divergence or difference derived from the interpretation or application of the MoU shall be resolved amicably between the Parties through mutual consultations. This MOU does not create any legal rights or obligations under any international or domestic law upon either Party.
