

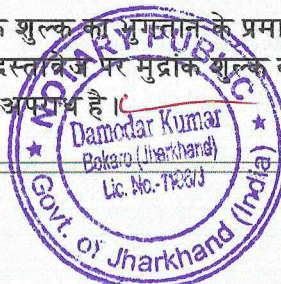

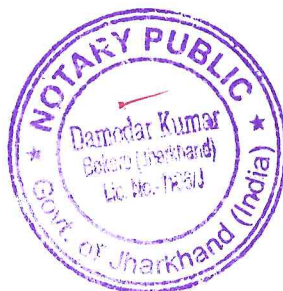
Adani Cement and the Guru Gobind Singh Educational Society’s Technical Campus are hereinafter individually referred to as “Party” and jointly as the “Parties”.

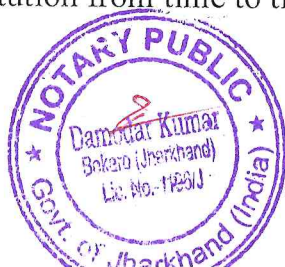
### **1. Partnership Recognitions**

branding, logo placement, acknowledgment in event materials, opportunities for representation etc.

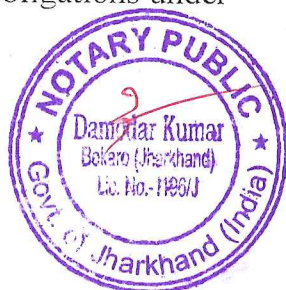

- All materials, content, and know-how shared by Adani Cement remain its exclusive property. The Partner Institution shall not reproduce, distribute, or use such materials for any purpose outside the scope of this partnership without written consent.

### 4. Confidentiality

- All information including, without limitation, oral and written information, disclosed by Adani Cement and/or its representative (including any experts appointed by the Adani Cement) or Adani Cement's personnel ("**Mr. Vinod Bahety**") to the Contractor or any Person acting for and on behalf of the Partner Institution ("**Dr. Priyadarshi Jaruhar**") is deemed to be confidential, restricted and proprietary to the Disclosing Party ("**Confidential Information**").
- The Confidential Information supplied is not to be reproduced in any form except as required to accomplish the intent of, and in accordance with the terms and conditions of this Agreement. The Receiving Party shall provide the same care as it provides to protect its own similar proprietary confidential information to avoid disclosure or unauthorized use of the Confidential Information. All Confidential Information shall be retained by the Receiving Party in a secure place with access limited to only such of the Receiving Party's personnel, employees or agents who need to know such Confidential Information for the purposes of completing the Scope of Work, performance of obligations under

This Agreement and to such third parties as the Disclosing Party has consented to by prior written approval. Unless otherwise specified in writing, all Confidential Information, including all copies thereof: (a) remains the property of the Disclosing Party; (b) shall be used by the Receiving Party only for the purpose for which it was intended; and (c) shall be returned to the Disclosing Party or or destroyed after the Receiving Party's need for it has expired or up on request of the Disclosing Party, and, in any event, upon expiration or termination of the Agreement. If required, at the request of the Disclosing Party, the Receiving Party shall furnish a certificate certifying that any Confidential Information not returned to Disclosing Party has been destroyed.

## **5. Term and Termination**

This Agreement is valid for an initial period of five years from the date of signing and either party may terminate this Agreement with 30days'written notice to the other party.

## **6. Governing Law and Dispute Resolution**

This Agreement shall be governed by and interpreted in accordance with the laws of the Republic of India.

Any disputes arising under this Agreement shall be referred to the courts at Ahmedabad, Gujarat, India and such courts shall have exclusive jurisdiction on all matters arising out of or relating to the Agreement.

## **7. Joint Declaration**


