Bhendra, Bokaro, Jharkhand, authority which expression, unless excluded by or repugnant to the subject or context shall include its successors- in-office, administrators and assignees).

GGSESTC and Bhendra Tools Industries Producer Co Ltd., Bhendra, Bokaro, Jharkhand are individually referred to as "Party" and collectively as the "Parties".

I.BACKGROUND

The students of GGSESTC will gain benefits by availing various learning opportunities under different area of Internship, Innovation in Bhendra Tools Industries Producer Co Ltd., Bhendar, Bokaro, Jharkhand initiatives.
- ⊕ Both GGSESTC, Kandra, chas, Bokaro and Bhendra Tools Industries Producer Co Ltd., Bhendar, Bokaro, Jharkhand being legal entities in themselves desire to sign this MOU for advancing their mutual interests.

II. Purpose & scope:

The purpose of the MOU is to clearly identify the intentions of both parties and to form a potential relationship in the future for working towards mass adoption of innovation in the entire serviceable.

III. Forms of Co-operation:

Within such fields as are mutually acceptable for the Parties, the following forms of co-operation, amongst others, may be pursued hereunder:

VI. Funding

This MOU is non-financial in its present form. This clause may be revised in future by Bhendra Tools Industries Producer Co Ltd., Bhendar, Bokaro, Jharkhand and GGSESTC, Kandra, chas, Bokaro subject to terms and conditions based on the delivery of results.

VII. Monitoring mechanism

Both the Parties will meet as often as possible in order to evaluate matters regarding the implementation of this MOU.

VIII. Financial Arrangements

Both Parties understand that all financial arrangements between the Parties have to be further negotiated and mutually agreed and will depend on the availability of funds. Both parties may seek financing of joint activities from internal and external sources available to them. It is the current form; the MoU is non-financial future financial agreement must be negotiated separately and are subject to the availability of funds.

IX. Legal Relationship

The document is a statement of purpose and does not create a legally binding relationship between the parties.

X. Commencement, Renewal, Termination

This MoU will be effective from the date of the last signature here to and will remain in force for a time period of three (3) years, with a possibility for renewal at the end of the three-year-period, subject to the Parties' written agreement. Either Party may terminate this MoU by giving seven (7) working days' notice in writing to the other Party.
